Ninth. I have resided continuously in the United States of America for the term of five years at least immediately preceding the date of this petition, to wit, since the 4 day of Oct, anno Domini 1 900, and in the State of Pennsylvania continuously next preceding the date of this petition, since the 4 day of Oct, anno Domini 1 900, being a residence within this State of at least one year next preceding the date of this petition.

Tenth. I have not heretofore made petition for citizenship to any court.
